 2. Outstanding projects update

 - (Sajan) Survey of Existing PMU applications Around the World and Classification
 - (Pratim) Analyzing Synchrophasor Performance Requirements for Synchrophasor based Control Applications
 - (Pratim) Data Quality Impacts on Synchrophasor based Control Applications
 - ✓ We have about 10-15 volunteers for each paper. Monthly meetings are being scheduled over the last four months. There are some volunteers from India and other places also.
 - ✓ The first draft of all the three papers is ready. We are now working on refining the inputs and finalizing the structure of the papers.

 - C37.242 (Allen Goldstein); Allen not on call. This information was from last month; ballot in and passed requirements, comments in, but haven't had an opportunity to address comments yet. Ken Martin asserted that he is part of this group and they haven't had any meetings since the last NASPI Work Group meeting.

- C37.118.2 (Vasudev Gharpure); Ken said this working group has not had any meetings for quite some time. No update from Vasudev at this time.

- [IEEE PES PSRC C23](#) (Allen Goldstein); - Jim asserted the September meeting planned for Reno, NV, will not be an in-person meeting but rather a virtual meeting, working out the details, looking for subcommittees to provide a person to manage all their meeting sessions as they will use WebEx.
